The regular public meeting of the Butler County Board of Commissioners was called to order by Chairman Leslie Osche at 10:05 a.m. on Wednesday, March 2, 2022, in the Public Meeting Room, 1st Floor Government Center.

PUBLIC COMMENT ON AGENDA ITEMS

No public comment was made.

APPROVAL OF MINUTES

Chairman Osche called for a motion to approve the February 16, 2022 Public Meeting minutes.

Commissioner Boozel made the motion; seconded by Commissioner Geyer. The motion carried unanimously.

BOARD OF ELECTIONS

Solicitor Wil White made the public announcement that there are three possisble poll site changes. They are as follows: Summit Township North, Butler City 2 and Butler City 4-1. Action on these changes will take place at the next public meeting, scheduled for March 16, 2022.

NEW BUSINESS

A. Treasurer

1. Diane Marburger requested approval of Resolution No. 2022-4, which designates, reaffirms, predesignates and adds certain banks, banking institutions or trust companies as approved depositories for Butler County funds.

D. Human Services – Area Agency on Aging

 Brandon Savochka requested approval of a revised Contract with Holly Deemer for a Line Dance Instructor at the Evans City Senior Center at the rate of \$45/per class, for the period 3/8/22 with a Termination with Cause Clause. The only change in the agreement is that classes will be weekly. There are no County funds involved; payment will be made out of the Aging Block Grant.

Commissioner Boozel made the motion; seconded by Commissioner Geyer. The motion carried unanimously.

E. Parks & Recreation

 Lance Welliver requested approval to appoint Barbara Anderson, Sales Manager, Butler County Tourism and Convention Bureau, as an At-Large Representative to the Butler County Parks and Recreation Advisory Board for the one-year term, 1/1/22 – 12/31/22. Ms. Anderson will be replacing Brianna Kaiser and filling her term from Tourism.

Commissioner Boozel made the motion; seconded by Commissioner Geyer. The motion carried unanimously.

F. Planning

 Chief Clerk Lori Altman requested approval of Amendment 15 with Trinity Services I, LLC for Prison Food Service at the cost of \$1.763/per meal, a .25/meal increase, effective 3/1/22 for the term of one year.

1. Solicitor Wil White requested approval of Resolution No. 2022-2, certifying the local match for the Butler Transit Authority in an amount of no less than \$34,890.

Commissioner Geyer made the motion; seconded by Commissioner Boozel. The motion carried unanimously.

2. Solicitor Wil White requested approval of Resolution No. 2022-3, certifying the local match for Section 1513 Funds for the State Operating Financial Assistance for the Butler Transit Authority in an amount of no less than \$63,714.

Commissioner Boozel made the motion; seconded by Commissioner Geyer. The motion carried unanimously.

3. Solicitor Wil White requested approval of Resolution No. 2022-5 authorizing the sale of the County's 2015 Ford E450 Super Duty van to Alliance for Non-Profit Resources, in the amount of \$4,500.

Commissioner Boozel made the motion; seconded by Commissioner Geyer. The motion carried unanimously.
