Dear Candidate:

Please read the following pages carefully. Each page contains information that is necessary for your petition to be correctly printed, completed, and filed. The nomination petition process is for Democrat and Republican candidates only.

**Note: All dates in this document are subject to change without notice.**

1. The first day for candidates to circulate and file petitions is **February 17, 2026**.
2. The last day for candidates to circulate and file petitions is **March 10, 2026 at 4:30 PM**.
3. Signatures obtained prior to or after the circulation dates are not valid.
4. The location for filing nomination petitions is (please note address below):

5. Completed petition packages consist of a petition with the required minimum number of signatures and a signed Statement of Circulator and a Candidate's Affidavit (notarized). If the candidate is unable to obtain a notary, the Unsworn Declaration in lieu of the Notarization can be submitted with the completed Candidate's Affidavit.
6. If you desire copies of your nomination petitions for your own records, it is suggested that you make such copies **BEFORE** you file petitions with the Butler County Elections Office. Once the nomination petitions are filed, they become Butler County property and are then subject to a copying fee of \$0.30 (thirty cents) per copied page.
7. Once the petition filing period closes, a list of candidates filed will be posted and updated as needed on the county's website.

**INCOMPLETE OR INCORRECTLY PRINTED PETITIONS MUST BE REJECTED!**

**IF YOU PRINT OR COPY THE NOMINATION PETITIONS:**

Petitions **MUST** be printed/copied as **DUPLEX** (double-sided, front and back, head-to-head) on PLAIN WHITE 8-1/2" x 11" (letter-size) paper. This requirement **CANNOT** be satisfied by printing each side of the nomination petition on a separate sheet of 8 1/2" x 11" paper and affixing the two sheets together with a staple, paper clip, or adhesive.

**FAILURE TO REPRODUCE THE NOMINATION PETITION FORMS CORRECTLY  
MUST RESULT IN REJECTION OF THOSE FORMS!**

**Instructions for Completing the Front of the Nomination Petition**

**All numbered blank lines**, which appear at the top of each nomination petition, must be completed **BEFORE** signatures are obtained. The following numbered instructions correspond with the numbered blank lines found on the nomination petition.

**1) ELECTORAL DISTRICT**

Write the name of the "Electoral District" in which the candidate is running. The electoral district is the county and geographical area represented by the office the candidate is seeking.

A. This election, the only candidates filing petitions at the Butler County Bureau of Elections are political committee people. The Electoral District is the **precinct** in which the committee person will be running.

i. Example: Adams Twp 1, Zelienople Boro 2, Butler City 3

**2) POLITICAL PARTY**

Enter the political party you choose to seek nomination ("Democrat" or "Republican").

**3) NAME OF CANDIDATE**

Type or print the name of the candidate on the face of the petition **EXACTLY** as the candidate wants it to appear on the ballot. Given names must be used. Titles such as Dr, Mr. or Mrs., etc. are not permitted. A nickname is allowed only if it is a derivative of the legal given name, unless an affidavit for primary ballot name change request is filed with our office.

**4) PROFESSION, BUSINESS, OR OCCUPATION**

For "Profession, Business, or Occupation," write your current job title, such as "Attorney," "Clerk," "Accountant," "Business Manager," "Secretary," or "Steel Worker." Simply putting initials such as VP, CEO, COO, CFO is not sufficient. (Note: Retired is an acceptable entry in this line.)

**5) PLACE OF RESIDENCE**

Enter your house number (apartment number, if applicable), street name, and ZIP code.

## 6) TITLE OF OFFICE

For “Title of Office” include the office in which you are seeking election. Committeeman, committeewoman, committee person, etc. Please refer to your party bylaws for the correct office language. The title of office must be filled in **BEFORE** you get signatures. If it is blank, when you try to turn in your petition it will be rejected.

## 7) TERM OF OFFICE

For “Term of Office” insert the duration of the term of the office for which you are seeking in number of years. The term is different for each party. Please consult your party bylaws for the correct term. The term length must be filled in **BEFORE** you get signatures.

### **Instructions for Circulating the Nomination Petitions**

#### **Minimum Number of Signatures:**

The minimum number of valid signatures required for each petition is 10, per state law.

#### **Requirements for Gathering Valid Signatures:**

To be considered a valid signature, the signature must meet the following requirements.

1. Each signer may sign petitions for as many candidates for each office as he or she is permitted to vote for, and no more. If the race is a vote for one, you may only sign one petition for that office.
2. Each signer of a petition must be a registered and enrolled elector of the party referred to in the petition. In other words, only Republican electors may sign Republican Petitions. Candidates may obtain one free street list from the Election Bureau prior to circulation to ensure all potential signers are of the correct party and district.
3. In addition to **PERSONALLY** signing and printing their names, each signer must **PERSONALLY** insert their place of residence and date of signing. Please note that this address may or may not be the same as one’s postal address and that **the Petition requires the signer to list their City, Borough or Township; for example, Summit Township NOT Herman**
4. **DO NOT ALLOW ANY SIGNER TO USE DITTO MARKS.** Each signer must complete all the required information themselves.
5. **AN INDIVIDUAL MAY ONLY SIGN FOR THEMSELVES. NO ONE IS PERMITTED TO SIGN THE PETITION FOR ANYONE ELSE. For example, husbands may not sign for wives and wives may not sign for husbands; parents may not sign for children and children may not sign for parents.**

**Note:** If a petition is challenged and signatures are declared invalid by a court, a candidate may be struck from the primary ballot if the remaining number of valid signatures on the petition falls under the minimum required number of valid signatures.

## **Statement of Circulator**

For **ALL PETITIONS**, the *Statement of Circulator* found at the top of the back page of the Petition must be signed **by the person who circulated** the petition **AFTER**, and only **after**, the necessary signatures are gathered. For the address section of the *Statement of Circulator* please note that it asks for postal address as well as the circulator's City, Borough or Township.

## **Instructions for Completing the Candidate Affidavit**

Each candidate must submit one *Candidate Affidavit*, along with the petitions containing the required minimum number of signatures. The Candidate affidavit must be signed by the candidate in front of a Notary Public, who will notarize the affidavit, OR may be attached to an Unsworn Declaration in lieu of notarization. The Unsworn Declaration only replaces the notary stamp. The Candidate must still fill out the Candidate Affidavit. On the Affidavit, the candidate will complete the information in the right column and the **Notary Public** will complete the information in the left column. For "Title and Term of Office" insert the exact title of the office for which you are running and the term of that office, as stipulated in the preamble of the nomination petition (Line 6 and 7).

## **Filing the Nomination Petition**

### **Sheet Numbers**

If you are submitting more than one sheet of petition signatures, fill in the sheet numbers in the bottom right corner; and number the pages consecutively.

## **Casting of Lots for Ballot Position**

If more than one (1) candidate is seeking the same office, then each candidate may draw in person or have a proxy draw in their place to determine the ballot position. Should the candidate designate a proxy, authorization must be made in writing and notarized. The casting of lots will take place **at noon on Wednesday, March 18<sup>th</sup>**, location to be announced. Once the petition filing period closes, a list of candidates filed will be posted on the County's website.

## **Important Notice Regarding Downloaded Nomination Petitions**

**Nomination petitions must be printed as duplex (two-sided, front and back) on plain white 8 1/2" x 11" (letter size) paper.** This requirement **cannot** be satisfied by printing each side of the duplex nomination petition on a separate sheet of 8 1/2" x 11" paper and affixing the two sheets together.

These forms are for candidates of the democratic and republican parties only. **Candidates of minor political parties and political bodies may not utilize these forms.**

Before downloading or printing any of the nomination petitions on this page, please read the following instructions very carefully. **Failure to reproduce the nomination petitions correctly will result in the rejection of those forms.**

All fields must be completed

Please read all instructions provided with the nomination petitions prior to circulation.

**Note: Altering any of the fields on the following pages may invalidate the content.**

## **NOTARIZATION**

- \_\_\_\_\_ Candidate's affidavit **MUST** include the Notary's signature and the official inked stamp indicating the municipality and expiration date of commission. Please note: Notary's embossed seal is not the official inked stamp.
  - ***If you are unable to have the Candidate's Affidavit notarized, you may complete and sign an unsworn declaration to submit with your petition materials. The Candidate's Affidavit must be filled out in addition to the unsworn declaration. The unsworn declaration only replaces the notary stamp on the candidate affidavit.***

It is the candidate's responsibility to insure that:

- If the petition was printed by anyone other than the Bureau of Elections, the petition was printed correctly (double sided and containing all information).
- Candidate is of the district and party named on petition.
- Circulator is of the party of the candidate.
- All signers are of the district and party of the candidate.

## **FILE EARLY**

**DO NOT WAIT UNTIL THE LAST DAY TO FILE. PLEASE ALLOW TIME TO MAKE ANY CORRECTIONS OR NECESSARY CHANGES.**





Signatures must be procured within the legal time period for securing same.
