WAIVER OF ARRAIGNMENT

I, the undersigned Defendant, understand that I am scheduled to appear for Arraignment on the above scheduled date, and verify that I understand:

- (1) The nature of the charges against me;
- (2) The right to file motions, including:
  - (a) A Request for a Bill of Particulars, as provided in Pa.R.Crim.P. 572, within (7) seven days of the Scheduled Arraignment Date;
  - (b) Motion for Discovery and Inspection, as provided in Pa.R.Crim.P. 573, before any disclosure or discovery can be sought under these rules by either party, counsel for the parties shall make a good faith effort to resolve all questions of discovery, and to provide information required or requested under these rules as to which there is no dispute. When there are items requested by party, which the other party has refused to disclose, the demanding party may make appropriate motion to the court. Such motion shall be made within (14) fourteen days of the Scheduled Arraignment Date, unless the time for filing is extended by the court;
  - (c) An Omnibus Pretrial Motion for Relief, as provided in Pa.R.Crim.P. 578 within (30) thirty days of the Scheduled Arraignment Date, unless the time for filing has been extended by the court for cause shown.
- (3) A defendant who intends to offer the defense of alibi at trial shall file written notice specifying an intention to claim such defense. A defendant who intends to offer at trial the defense of insanity or a claim of mental infirmity shall file written notice specifying an intention to claim such defense. Such notice shall be filed within (30) thirty days of the Scheduled Arraignment Date.
- (4) I, hereby, waive my right to appear for Arraignment. I understand that a copy of the Information to be filed against me and a copy of my Criminal Case Scheduling Form shall be served upon me by first class mail addressed to my place of residence, and that **I fail to appear in the Butler County Courthouse on the dates and times provided on the Criminal Case Scheduling Form, a Bench Warrant or Bail Piece may be issued for my arrest.**
