

ADULT PROBATION OFFICE OF BUTLER COUNTY
CONDITIONS GOVERNING PROBATION AND PAROLE

TO: _____, upon the Order of Judge _____
dated _____, _____, you are under the supervision of the Butler County Adult Probation Department until the expiration of your probation/parole or further Order of the Court.

You are subject to the following conditions of supervision:

1. Report to your Probation Officer in such manner as directed, and abide by any written or verbal instructions of the Probation Department. Also, you will reply promptly to correspondence from the Probation Office.
2. Obtain permission from your Probation Officer prior to changing your address/residence.
3. Comply with all Municipal, State and Federal criminal laws, as well as the provisions of the Vehicle Code (75 Pa.C.S. §101 *et seq.*) and the Liquor Code (47 P.S. §1-101 *et seq.*). Notify your Probation Officer within 72 hours of any police questioning, investigations or arrest, even if you are cited without being apprehended. It is also your obligation to inform the arresting officer that you are on probation/parole.
4. Make every effort to obtain and maintain employment and support yourself and any legal dependents. Obtain permission prior to changing employment. Notify your Probation Officer immediately if you lose your employment.
5. Do not travel outside of Butler County/Pennsylvania without prior permission from your Probation Officer.
6. Do not use alcoholic beverage. You are not to enter places whose business is primarily the sale of such beverages. Abstain from the possession, use or sale of narcotics and other illegal drugs within the meaning of the Controlled Substance, Drug, Device and Cosmetic Act without a valid prescription.
7. You may not own, possess or have under your control any type of firearm or other deadly weapons.
8. You will permit the search of your person, vehicle, residence or any property under your control by the Probation Officer and/or his agent and any contraband found is subject to seizure by your Probation Officer and may be used as evidence.
9. When ordered by your Probation Officer, you will submit to any tests that are available to determine whether you have been using drugs and/or alcohol.
10. Refrain from behavior which threatens or presents a clear and present danger to yourself or others.
11. Comply with the following conditions of sentence and any special conditions which may subsequently be imposed by your Probation Officer:
 - A. You are subject to pay costs, fines and restitution imposed by the Court and/or abide by any payment schedules established.
 - B. Attend the Drug and Alcohol School and pay the required fee for this school.
 - C. Participate in any counseling and/or treatment as directed.
 - D. Perform _____ hours of Community Service.
 - E.

The Probation Officer has the authority at any time during this period, in case of alleged violation by you of any of the conditions of your probation/parole, to arrest you with or without warrant, writ or rule. The Department has the authority to incarcerate you in a county prison and place a detainer against you which will prevent you from being released. In the case of a probationer, the Court may, after appropriate hearings, revoke the probation and commit the violator to a correctional institution to serve a sentence. In the case of a parolee, the Court may, after appropriate hearings, recommit convicted parole violators to serve the balance of their sentence with no credit given for time at liberty on parole.

Your probation/parole is expressly conditioned upon your waiving extradition to the Commonwealth of Pennsylvania from any jurisdiction in or outside the United States, where you may be found, and upon your not contesting any effort by any jurisdiction to return you to the United States or the Commonwealth of Pennsylvania.

If you believe any of your rights have been violated as a result of your supervision, you may submit a timely complaint in writing, first to the Chief Probation Officer. If your complaint is not resolved to your satisfaction, you may then submit your complaint in writing to the President Judge of Butler County, PA.

I hereby acknowledge that I have read, or have had read to me, the above said conditions of my probation/parole; I fully understand them and agree to follow them; and fully understand the penalties involved should I, in any manner, violate them.
